- Identify, analyse and evaluate situations which are significant in special educational needs terms
- Provide diagnosis, advice and support within the context of individual case related support diagnostics
- Plan, implement and document special educational needs development and life supervision
- Apply occupationally specific forms of action in pedagogical or therapeutic work
- Identify the interests of affected parties within their socio-cultural and societal system of reference
- Design situation, process and solution oriented cooperation arrangements which are conducive to development
- Apply substantiated knowledge of initial and further diagnostics
- Implement measures for
 - Promoting sensory perception
 - Special needs exercise treatment
 - The promotion of speech and communication
 - Basal pedagogy activation
 - Special needs support through play
 - Psychomotor support
 - Special needs environment design
 - Musical and rhythmic support
 - Behaviour modification
- Design interdisciplinary cooperation and networking
- Carry out colleague supervision and evaluation
- Apply substantiated business administration and legal knowledge in the structuring of special needs educational activities
- Develop structural and design concepts for the respective work or organisational unit
- Accord due consideration to basic legal principles relevant to the occupation in providing assistance, support and care and in dealing with administrative matters within the given administration structures
- Develop a sense of initiative and assume responsibility within remedial therapy processes
- Use knowledge of foreign languages in a way which is adequate to the situation
- Demonstrate ethical, economic and ecological awareness within the context of sustainable development

State final examination:

1. following completion of training within the scope of the curriculum stipulated at a trade and technical school/ trade and technical academy or
2. following admission as a non-pupil by the education authority of the federal state.

Additional information

Entry requirements: Persons who have obtained a qualification as "State-recognised educator", "State-recognised remedial therapist" or who are in possession of a qualification recognised as equivalent within the country and have worked on a full-time basis for a period of at least one year performing a practical activity in a social education or special educational institution are admitted to the training.

Duration of training: at least 1,800 hours

Educational aim: Trade and technical schools/trade and technical academies are institutions which provide continuing vocational training for the assumption of management tasks. Trade and technical schools/trade and technical academies offer a range of organisational forms of teaching (full-time or part-time basis) which lead to a post-secondary state vocational education and training qualification in accordance with federal state law.
